Our professional legal team and extended global network, combines decades of experience in international law, Israel advocacy and combating antisemitism, in a determined, proactive and professional manner.

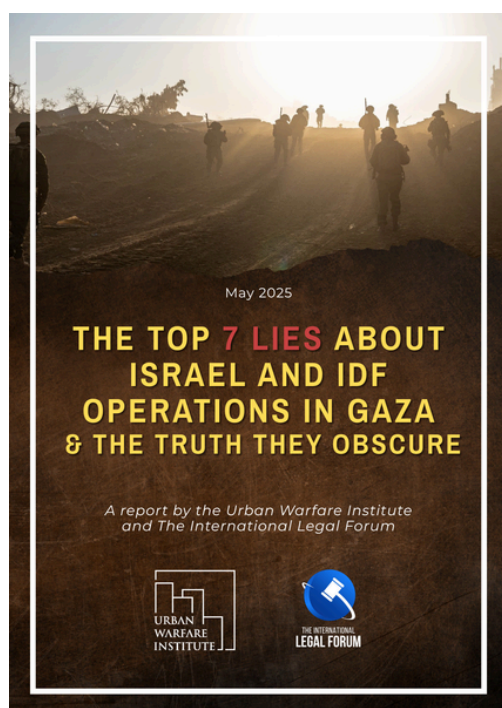
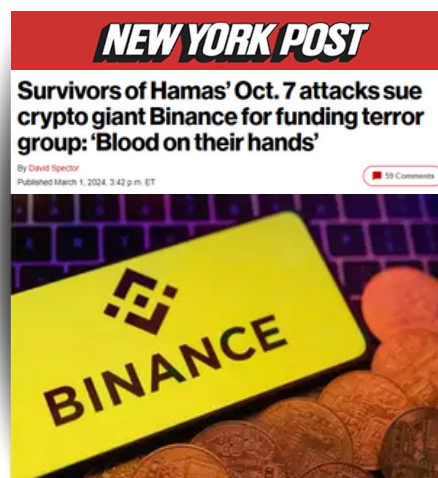
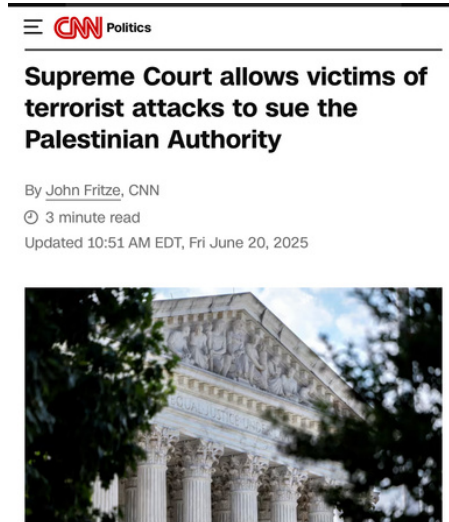
OUR METHODS INCLUDE

KEY ACTIONS & ACHIEVEMENTS

- Submitted first international war crimes claim against Hamas, the Palestinian Authority and Iran.
- Won a unanimous precedent-setting victory in the U.S. Supreme Court, which ruled that American victims of Palestinian terror can sue the Palestinian Authority and the PLO in U.S. courts, including over Pay-for-Slay payments.
- Together with our partners in the U.S., filed a number of groundbreaking lawsuits after the October 7th attacks, including against Students for Justice in Palestine, Columbia University, UNRWA USA, Binance Cryptocurrency and U.S.-based Palestinian charities, over complicity with Hamas and fuelling antisemitism.
- All the lawsuits have been filed on behalf of Oct. 7th victims, survivors, hostage families and American nationals, including students on campus.
- The lawsuits have already resulted in some dramatic changes, including revocation of tax status, Department of Justice investigations, cuts in funding and amendment of federal legislation.
- Succeeded in removing UNRWA from a leading donor advisory platform.
- Was instrumental in legal campaign to have PFLP and Hamas affiliated group Samidoun, designated as a terror entity in the U.S. and Canada.
- Stood up for Israel and the IDF at The Hague, against the baseless charges of 'genocide' at the International Court of Justice.
- Together with our partners, led the legal appeal against the outrageous war crime charges against the Israeli Prime Minister and Defense Minister at the International Criminal Court.
- Produced and distributed real-time legal material on Oct 7th war, Gaza humanitarian issues and the war with Iran. This included FAQ Reports, material translated in different languages, and supported also with educational videos, multimedia and infographics. The material was also constantly updated.
- Briefed parliaments and lawmakers in US, Britain, Canada, Europe and Knesset on lawfare challenges facing Israel and their implications.
- ILF has been at the forefront of making the case for Israel and defending the Jewish state in the international legal arena on leading media platforms, ranging from major television networks to top-tier newspapers and publications worldwide, and well as across digital platforms.
